One Tuesday in June and two in July, children are invited to be a part of Terrific Tuesdays which include games, sports, swimming, and learning of God's love for us and how to share it! Tuesday, June 12 and July 10 will begin at 9 a.m. at the church and end at 4:30 p.m. Tuesday, July 31 will begin at 8 a.m. and end at 5 p.m. Cost for children K-5th grade is \$10 for each Tuesday with early registration before June 8th and \$15 after this date. This includes lunch, snacks, activities, tickets, and transportation.

Pre-school Program Information

Our preschool program (ages 2 1/2 —4 years old) will begin at 9 a.m. and end at 12:30 p.m. on Tuesday, June 12 and July 10. The preschool children are invited to join us for the afternoon activities, however, if your preschooler is attending the afternoon activity on July 10 there must be a parent available to attend with them for liability purposes due to this being a swim activity. On July 31, all preschool - 5th graders will be visiting the Ripley's Aquarium in Gatlinburg, TN. We will be leaving at 8 a.m. and returning at 5 p.m. (There is a \$10 charge per child if attending the afternoon activities and the Aquarium). Please register by June 8.
